IFRS 15 replaces existing regulations

The core principle of IFRS 15 is that an entity will recognise revenue to depict the transfer of promised goods or services to customers in an amount that reflects the consideration to which the entity expects to be entitled. With a few exceptions, such as leasing agreements, the new IFRS 15 standard is to be applied toall contracts a company signs with its customers.

IFRS 15 is set to replace different current standards applied to revenue recognition, such as IAS 18 for sales revenues or IAS 11 for construction contracts. Revenue recognition can be fulfilled as per the new standard using a five-step model (see Fig. 1).

Fig. 1: Five-step model of revenue recognition




Fig. 2: IFRS15.easy architecture
